Data supply by the DPMA

It is the statutory duty of the German Patent and Trade Mark Office (DPMA) to offer information to the public about IP rights valid in Germany. We therefore offer publication and search services on the Internet. The machine-readable data generated for the databases will also be supplied to third parties. They can use the data for the creation, development or maintenance of their own IP databases as well as other information systems and services. This is subject to signing an agreement and carrying the costs for the supply of the data. The DPMA thereby promotes the distribution and use of German IP information.

We offer the data via the following services:

DPMAdatenabgabe

- download of the weekly publications: documents relating to patents and utility models; publications relating to trade marks and designs; bibliographic data as well as updates of the legal and procedural status data
- backfile data

DPMAconnect

web service interface with DPMAregister: access to data of the official registers

DEPATISconnect

web service interface with DEPATISnet: download of the documents relating to German IP rights

DPMAdatenabgabe

We provide current IP data and documents in a secure download section on a weekly basis. The publications relating to patents and utility models are usually published on Thursday, the ones relating to trade marks and designs on Friday.

Category of data and format

- bibliographic data as well as legal and procedural status data relating to patents/utility models, trade marks and designs in XML format
- documents in the original layout in PDF format
- data from documents and publications in XML format with drawings in TIFF format and pictures in JPG format

Costs

For the supply of data, 20 euros will be charged for each category of data and for each publication week.

DPMAconnect

The service offers direct access to **DPMAregister**. The data can be automatically downloaded via a web service interface and used for the creation, development or maintenance of your own IP databases as well as other information systems and services.

Available data

Patents und utility models:

all data available since 1 January 1981 and daily update of legal status data for published applications and granted patents, registered utility models, topographies, supplementary protection certificates for medicinal and plant protection products

Trade marks:

all register data on all currently registered trade marks (with filing date as from 1894); complete file history of German trade mark applications, refused or withdrawn German trade mark applications and cancelled German trade marks as from 1 January 1998; indications of geographical origin (only applications)

It is planned to supply design data via **DPMAconnect** in future.

Costs

Access is free of charge.

DEPATISconnect

Access to the **DEPATIS** document archive is based on an Internet leased line with a registered and non-dynamic IP address. Via the interface, you can download the German IP documents in PDF format and optionally the corresponding bibliographic data in XML format.

You can retrieve the data via the document identification number, consisting of the country code, document number and kind code. However, you cannot search within the available data.

Available data

- documents of the German Patent and Trade Mark Office
- documents of the patent office of the former GDR
- documents of the European Patent Office (EPO) effective for Germany
- documents of the World Intellectual Property
 Organization (WIPO) effective for Germany

Costs

For the supply of data, a one-time payment for connection of 250 euros and annual costs for use of 2,500 euros will be charged.
